McLaughlin Boat Works Limited Warranty for Rigid Inflatable Boats

McLaughlin Boat Works (MBW) warrants to the original purchaser of a new Rigid Inflatable Boat (RIB) hull imported by MBW to be free from defects in materials and workmanship for three (3) years from the date of purchase, under normal, non-commercial use and service. MBW obligations under this warranty are limited to parts and labor for the repair or replacement of any part or parts, associated with the hull, tubes, or stainless steel fittings, which are found to be defective. Any shipping charges or freight charges under this warranty shall be the responsibility of the purchaser. MBW must do all warranty work unless prior authorization for other arrangements has been given in writing.

This warranty does not cover and is intended to exclude, any liability on the part of MBW, whether under this warranty or under any warranty implied by law for any indirect or consequential damages for breach hereof or thereof.

This warranty shall not apply to any hull, which has been subject to misuse, neglect, accident, alteration or repair made by other than an authorized MBW agent, nor to any repair necessitated by normal usage. This warranty, together with any and all warranties implied by law, shall be limited to duration of three (3) years from the date of purchase by the original consumer of the hull.

MBW makes no warranty in respect to parts and accessories not associated with the hull, specifically the motor. However, certain manufacturers of such parts and accessories may provide supplemental warranty coverage. Inquires concerning defects in parts and accessories not of our manufacture should be forwarded to MBW at the address set forth below. Return of parts for inspection to MBW will be at the owner's expense. MBW will, upon receipt of the questioned part, determine whether a defect is involved. MBW will continue to work with customer to resolve the issue in a manner, which is fair to all parties.

You may secure performance of warranty obligations hereunder by:

1. Contacting an MBW for an appointment to have the boat examined.
2. Delivering your boat to MBW for his/her examination.
4. Upon completion of warranty obligations MBW will notify you of the availability of your boat for your pickup.
